- DIO shall not be a party to such contractual or financial arrangements.

10. Emoluments to Experts:

Experts engaged by DIO shall be paid for lectures, workshops, mentoring sessions etc. as per the rates mentioned below:

Honorarium: ₹10,000 per day (expecting two sessions of up to three hours each)

Travel: Reimbursement of AC-I/Executive Chair Car rail fare or Economy Class airfare, as applicable, for outstation experts. Local taxi fare for travel for official local travel in connection with the assignment, shall also be reimbursable on actuals;

Accommodation and Daily Allowance: As per DIO policy applicable to CL-3 level (presently DA @ ₹1,250 per day and accommodation up to ₹5,625 per day plus applicable taxes).

11. Validity of Panel
