<u>Subject</u>: - <u>Lok Sabha provisionally admitted Parliament Unstarred Question Dy No 15423 for answer on 04.04.2025 reg 'Ancillary Defence Manufacturing Units in Amritsar'</u>

- a. Request Government to propose setting up small ancillary defence manufacturing units in Amritsar, given its strategic location on the border belt;
- b. Whether Govt. recognizes the potential benefits of establishing such units in Amritsar, including enhanced defence preparedness, economic growth, employment generation for the local population;
- d. Whether they will consider initiating such a proposal in consultation with other concerned ministries, recognizing Amritsar's strategic significance and its capacity to supply to neighbouring states and strengthen national security;
- e. The steps being taken to promote defence-related infrastructure and self-reliance in border areas, specific support being extended to local industries and small businesses involved in defence production.

This question seeks to highlight the strategic and economic importance of setting up defence ancillary units in Amritsar and aims to secure a comprehensive response from the Ministry of Defence.
